Queensland dominated the teams challenge with both teams reaching the final with Queensland Red taking out the championship by defeating Queensland Blue.

The National Junior Championships were again a huge success with a record number of participants.

The only ranking event held was the Dr Clem Jones AO Open Snooker Championship, which was held at the Redcliffe Snooker Club, Qld. 48 players competed with Kurt Dunham defeating Adrian Law in the final, five frames to four.

Congratulations to Kurt and Adrian for a closely fought final. Daniel Haenga had the highest break with a dazzling 134.

Australia were to host a qualifying Rokit Phones Senior event early this year but along with most of our championships we had to cancel. Once we have a better indication of the lifting of National and International restrictions we will reschedule.

Nomination for Life Membership of the ABSC - Mike Peachey (WA)

Criteria for awarding ABSC Life Membership for outstanding service to cue sports in Australia

- No. 1 Criteria for awarding Life Membership to a person being a member of ABSC or one of its Affiliate members. That person must have been a member for a period not less than 60 years, and be nominated by his affiliated member for meritorious events in his time as a member.
- No. 2 Criteria for awarding Life Membership to a person solely on Administrative contribution to ABSC or an affiliated member, that person must have served ABSC or its affiliated member for a period not less than 40 years
- No. 3 Criteria for awarding Life Membership to a person solely on Administrative contribution to the ABSC, That person must have served ABSC as a delegate and or Board member for a period not less than 20 years
- No. 4 Criteria for awarding Life Membership to a person solely on Administrative contribution to the ABSC,
 That person must have served ABSC as a Board member for a period not less than 10 years
- No. 5 Criteria for awarding Life Membership to a person solely on Administrative contribution to the ABSC, That person must have served ABSC as a President or Vice President for a period not less than 6 years
- No. 6 Criteria for awarding Life Membership to a person solely on playing record,
 That person must be a member or ABSC or one of its affiliates and have a exemplary record in
 International, National competitions, in consideration of the players eligibility preference will be given to:
 - a. rankings as a Professional player who has achieved a ranking of 10 or less
 - b. Players who have won WPBSA or IBSF Championships
 - c. Players who have competed in at least 10 WPBSA or IBSF recognised Championships.
 - d. Players who have been ranked 10 or below in the Australian Ranking scheme for a minimum period of 10 years.

Mike Peachey (WA)

- A former member of the committee of WAB&SA
- Was a West Australia delegate to ABSC in 1990.
- A former President of WAB&SA
- Joined the ABSC Executive in 1992
- Was elected President of ABSC in 2001 and served the maximum of six years
- Was President of OBSF 2001 to 2007
- Was a Board member of IBSF 2001 to 2007
- Very much active with WPBSA, especially in the Oceania region
- Board member of WCBS 2005-2010
- WCBS Organising Committee to the 2009 World Games in Chinese Taipei
- WSF Board member 2017 present
- Still an active member of WAB&SA

Notes in support of Mike Peachey for Life Membership of ABSC

- Mike qualifies under the Criteria No 2, No 4 and No 5
- Mike is the only President of Council not to be elected Life Membership, apart from D M Law (Qld) who was President in 1978-1980, following the death of Bob O'Neill.

Criteria for awarding ABSC Life Membership for outstanding service to cue sports in Australia

- No. 1 Criteria for awarding Life Membership to a person being a member of ABSC or one of its Affiliate members. That person must have been a member for a period not less than 60 years, and be nominated by his affiliated member for meritorious events in his time as a member.

- No. 5 Criteria for awarding Life Membership to a person solely on Administrative contribution to the ABSC, That person must have served ABSC as a President or Vice President for a period not less than 6 years
- No. 6 Criteria for awarding Life Membership to a person solely on playing record,
 That person must be a member or ABSC or one of its affiliates and have a exemplary record in
 International, National competitions, in consideration of the players eligibility preference will be given to:
 - e. rankings as a Professional player who has achieved a ranking of 10 or less
 - f. Players who have won WPBSA or IBSF Championships
 - g. Players who have competed in at least 10 WPBSA or IBSF recognised Championships.
 - h. Players who have been ranked 10 or below in the Australian Ranking scheme for a minimum period of 10 years.

Ron Stecum (Victoria)

- Was a long-standing member of the RACV Club
- Was elected to the committee of VBSA in early 1970's
- Was a Victorian delegate to ABSC in 1980's
- Was elected President of VBSA from 1978-82 and 1986-88
- Is a Life Member of the VBSA
- Joined the ABSC Executive in 1982
- Was elected Senior Vice President of ABSC in 1985 and held the position until 1992
- Aged 93 or 94 and is still an active member of VBSA

Notes in support of Ron Stecum for Life Membership of ABSC

- Ron qualifies under the Criteria No 1, No 2, No 4 and No 5
- We have precedents of members being awarded Life Membership having been a Vice President of Council.
 - o Les Cross (SA) was a VP in the 1980's. He was acting President when Bob O'Neil died.
 - o John McKay (Vic) was Vice President for many years from 1992.
