Playing conditions

Matches will be played on a roll-on roll-off basis in the playing order listed, wherever possible.

The first 5 matches listed each day will commence at 8:45am, players in later matches will be required from 9:30am. Later session times are an approximation only, players may be required at any time from the time listed. It is the responsibility of the player to be available in the room at the time their match is called to the table.

Round Robin matches are the best of 5 frames. Due to the busy schedule and limited time, players are requested to be mindful of the speed of their play, especially regarding excessive safety play and refusing to concede frames when a number of snookers are required. Matches which are not completed in a timely manner may be deferred at the discretion of the Tournament Director.

Dress Code

Long sleeve predominately plain coloured shirts buttoned at the wrist, bow ties and dark colour dress shoes must be worn for all matches. Waistcoat is required for the knockout stage. *Note that bow ties must be worn – a standard neck tie is not acceptable.*
